Definitions

Start Time of Game	Time indicated on game assignment in Arbiter. (AHRA requirement is on-ice officials arrive 20 minutes prior to game and off-ice officials arrive 10 minutes prior to game)		
Late Show	Not on ice or in scorekeeper's area at scheduled start time of game.		
No-Show	Not at game site for entirety of game assignment.		
Late Turnback	Notifying assigner that official will be unable to complete an accepted assignment less than 48 hours prior to start time of game.		
Game Fee Fine	Amount in Arbiter the official was set to earn for the assignment.		
Missing USA Hockey Game Report	Failure of submitting required incident report on USAH website within 24 hours. Penalties shall be applied to all referees (excluding linesman) working the game.		
Missing Scoresheets	Failure of providing a pdf of completed and signed scoresheet to <u>ahrascoresheets@gmail.com</u> after conclusion of assignment.		
Suspended Indefinitely Pending Disciplinary Hearing	Official will be removed from all future game assignments. AHRA Ethics & Conduct Committee shall determine the appropriate sanction as outlined by Article 11 of Association By-Laws
